Only one single family dwelling of not less than one thousand five hundred (1,500) square feet of interior heated space shall be allowed on each Lot. The main dwelling must have at least one double car enclosed garage. Carports may be allowed in addition to, but not instead of, this requirement.

2. Except as specifically amended hereby, all of the covenants,

restrictions, terms and conditions of the Declaration shall remain in full force and effect.
